ADMINISTRATIVE AGREEMENT

IN-CAR COURSE LENGTH: The Virginia State Drivers, education program consist of two phases. *In the observation*, normally two periods of instructions are given during each session.

DRIVER'S EDUCATION PROGRAME: Students 18 years of age and under are required to complete a state approved driver's education program prior to receive a driver's license. Students 18 years of age and older may hold the learner's permit for 60 days in lieu of completion prior *IN-CAR* instructions.

ATTENTION: Attendance at a D.T.S is not required by a student over 18 years of age in order to secure a driver license.

SCHEDULING: Each period of instruction is 50 minutes. *IN-CAR* students are responsible for scheduling *IN-CAR* instructions. We have found that scheduling your next lesson while *IN-CAR* works best. Your start Date is _____.

METHOD OF PAYMENT: We accept personal checks, Cashier's checks, all major credit cards and cash.

FEES:

Adult Waiver Program (no DMV road test) Classroom and Behind the Wheel training \$ 450 * Adult waiver program includes 30 hours of classroom or **online drivers education instructions** and 7 sessions of behind the wheel training. If the student is not a confident driver after receiving 7 hours of behind the wheel instructions, they may purchase additional training at \$35 per hour. **AA Plus Driving School** will NOT issue a license to an unprepared driver. _____

Fee for this course is: Behind the Wheels and Driver Edu, \$475.00 (For Students under 18).

Fee for adult (per hour): \$50.00- *Driving test* service \$100.00 (for adults).

Fee for *IN-CLASS INSTRUCTIONS* is \$250.00 for under the age 18. **ONLINE DRIVER'S EDUCATION COURSE \$199.00** Email -----

Fee for KNOWLEDGE TEST REEXAMINATION is \$ 250.00 for 36 or \$175.00 for 8 hours of class instructions.

Behind the wheel and *IN-CAR* tuition is paid in advance of instructions. There will be a \$35.00 fee for any returned checks. The returned checks fee doubles if payment arrangements are not made within wee of notification.

REFUND: A statement that a refund of any fees or tuition or any part of fees or tuition must be provided upon request unless the school is capable or willing to perform its part of the contract within a reason time period.

LESSON CANCELLATION: students **MUST** cancel / reschedule *IN-CAR* lessons at least 24 hours in advance or be subject to a \$25.00 fee. If for any reason the school decides to cancel a lesson, the student will be notified at the phone number listed below and the session will be researched at a convenient time for both parties.

DISCLAIMER: Be it known that there is **NO** guarantee that any student will pass the state license examination or that can secure license, or that the student will be guaranteed employment upon completion of course.
